

[UC]² Data Policy - Version 2.0

Working Group (WG) Data Management – WG Leader: Dieter Scherer

Release date: 27.03.2020

This data policy holds for all data provided by the [UC]² data management system (DMS) or by other data repositories granting access to [UC]² data for collaborative research.

In Phase I of the research programme “Urban Climate Under Change” - [UC]², funded by the German Federal Ministry of Education and Research (BMBF) from June 2016 until May 2019, a DMS for distribution of data to be used for collaborative research between partners of the four consortia MOSAIK, 3DO, KliMoPrax and UseUCLim participating in the [UC]² research programme was operated. In Phase II of the research programme, starting in September 2019, the DMS will be continued for the partners of the research programme. Due to structural changes in Modul C (only one consortium left in Phase II) and renaming of the consortia into MOSAIK-2, 3DO+M and Propolis, data policy has to be supplemented by three new licences.

The [UC]² DMS will be maintained during the entire funding period of Phase I and II, for which this data policy applies. During this period the [UC]² DMS will provide data exclusively to partners of the [UC]² consortium, since an account is required for accessing the [UC]² DMS. The data policy remains valid for [UC]² data to be provided by other means for collaborative research after termination of the [UC]² research programme.

Data that are intended to be uploaded to the [UC]² DMS must use one of the ten variants of data licences that have been defined by [UC]²:

MOSAIK Licence

MOSAIK-2 Licence

3DO Licence

3DO+M Licence

KliMoPrax Licence

UseUCLim Licence

ProPolis Licence

[UC]² Restricted Licence

[UC]² Research Licence

[UC]² Open Licence

The respective data licence must be specified in the global attribute **licence** in the NetCDF file in which the data are stored. Other data formats that are supported by the [UC]² DMS may use different methods for indication of the respective licence.

Specific conditions of use apply to each of the data licence variants, which are described in the following. In addition, any NetCDF file containing data to be uploaded to the [UC]² DMS must strictly adhere to the conventions defined by the [UC]² data standard.

Use of the **[UC]² Research Licence** or the **[UC]² Open Licence** as specified below is highly recommended to all partners of the [UC]² consortium providing data for collaborative research, since the [UC]² research programme intends to follow and support an open data policy. As soon as data that are stored in NetCDF files have been published, the respective NetCDF file(s) shall include

the reference in the global attribute **references**. One of the **[UC]² Research Licence** or the **[UC]² Open Licence** shall be used subsequently. If data that have previously been uploaded to the [UC]² DMS using one of the restrictive data licence variants have been published, a new version of the file(s) in which the data are stored shall be generated and uploaded to the [UC]² DMS again.

Data that are not intended to be uploaded to the [UC]² DMS may follow individual data policies as defined by the partner who owns the data. The partners are free to decide upon distribution of their own data by other means. If such data are shared with subsequent users, the data shall nevertheless adhere to the conventions defined by the [UC]² data standard, although this is not an obligation.
